K. Coastside Fire Protection District Plan to Address CalPERS Debt

Director Burke spoke of the Stanford individual who may come to speak to the Board regarding CalPERS. He also asked the Board to pass two motions, one of which, a statement of intent, did not receive a second following Board discussion.

Director Burke made a motion and President Mackintosh seconded, that the Board establish a dedicated reserve goal of \$5 million to be funded by June 30, 2016 to be used to reduce or eliminate the District's liability to the CalPERS retirement system. After Board discussion, Staff was directed to bring this back in written form at the next Board meeting with Staff analysis of the effect on the budget.
