1. OPEN SESSION

4. PUBLIC COMMENT

The Board heard public comments from members of the audience.

5. PUBLIC COMMENT – LOCAL 2881

Chris Leddy of Local 2881 discussed the Public Service Announcements in the Half Moon Bay Review and on the District's website. He reported some of the activities the firefighters have been doing. He stated there has been an increase in building permit applications, and he discussed several recent incidents.
