Joe Armenta with Redistricting Partners held a workshop to discuss the redistricting process and the maps that have been provided to the Board of Directors. Mr. Armenta recreated the maps to discuss the neighborhoods within the census blocks/districts.

The Public Comment period opened and closed at 3:15 p.m.

Committee discussion occurred regarding draft Map C. Directors MacKimmie and Sherrill discussed which neighborhoods should be moved to different districts to keep them contiguous. Mr. Armenta discussed the changes in deviation by moving areas to different districts.

Regarding draft Map A, Directors MacKimmie and Sherrill discussed splitting districts around Highway 1 and Highway 92 and after the City of Half Moon Bay, along with the Moss Beach area. Mr. Armenta discussed the reasoning on why certain areas were split into separate districts due to the population numbers.

Further discussions were had regarding moving areas to different districts. Draft Maps A, B, and C were revised.
