Secretary McShane initiated a discussion about the Paradise fire and one local firefighter who lost his home in that fire.

A. Finance Committee Report

President Burke indicated there was no meeting this month. He pointed out a few items on the Statistics Report. He also discussed the PARS report.

Chief Larkin responded to questions by Director MacKimmie on the monthly expense report.

B. Volunteer Liaison Report

Vice President Cockrell reported on the November 1st meeting. They discussed contributions to worthy causes such as burn victims, Coastside Hope, etc. They donated \$1,000 to the firefighter who lost his home in the Paradise fire. There is a new training officer, Bob Simmons. The treasurer made a report. They recently received a \$10,000 donation from Sky Moon Ranch following a wildland fire. The volunteers discussed the meeting they had with Chief Larkin.

Chief Larkin discussed his meeting with the volunteers.

C. Land and Structures Committee Report

Vice President Cockrell stated there will be a Closed Session later this evening with the real property negotiators.

Director MacKimmie reported on the status of Station 41. They are one and a half months ahead of schedule according to the project manager. Director MacKimmie discussed several aspects of the construction.

F. Emergency Preparedness

Director Stockman reported that he, President Burke, Chief Larkin, and the OES Captain had a meeting to further define OES's responsibilities.

He indicated that at the last CEAP meeting, it was revealed that there are now contracts with OES and the Red Cross to put 3 new shelters on the Coast in case of a disaster.

He stated that Judy Engel of Senior Coastside spoke very highly of the crew and the Training Prop. after they were given a tour and lunch.

He said OES discussed El Niño light and the expected weather on the Coast.

He indicated that Red Cross spoke about the Northern California fires and all the volunteers that participated in those fires. He said that San Mateo County has 125 volunteers who assist with persons who are misplaced due to fire loss.

H. Fire Chief's Report

Chief Larkin referred to the updated Statistics Report.

He discussed some recent fires on the Coast.

He indicated they have filled the vacant position of Fire Captain with Bob Simmons, and he discussed his qualifications.

He indicated he continues to work on the District of Distinction and he will be contacting the Board members for what needs to be done.

Chief Larkin reported that the new Half Moon Bay City Manager invited him to make a brief presentation at a recent City Council meeting.

Chief Larkin made additional comments about the recent OES meeting.
