Deputy Chief Jonathan Cox indicated he is there to implement what the Board wants as a staff member. He appreciates including asking for information on the Cal Fire contract.

President Burke indicated the basic item is to stay within the mission of the organization and the plan should not be subjective.

Vice President Cockrell suggested if everything is working correctly, don't make any changes. If there is an issue, then the Board should be made aware of it.

Director MacKimmie indicated new initiatives are needed with new dates inserted. He has no interest in rotating committee assignments.

President Burke indicated the Board Policy Manual states consideration should be given to relevant training and experience that Board members have when assigning to committees.

President Burke suggested an ad hoc committee be created to prepare a list of items to be brought to the Board for discussion and education.

Director Sherrill indicated they are looking for a path forward and there is a list of items she is interested in discussing in the document she provided to the Board.

Director Stockman understands the comments that operations are moving along fine. He believes additional educational opportunities should be presented to educate the Board and public. The Board should look forward to how it can be performing better.

President Burke asked Director Sherrill to put together a list of educational items for the Board to review at a future Board meeting.
