

STAFF REPORT

SUBJECT: CONSIDER FOR APPROVAL A RESOLUTION TO RECOVER COSTS FOR WEED ABATEMENT IN THE AMOUNT OF \$29,178.48 FOR 58 PARCELS

RECOMMENDATION

1. That the Board of Directors accept the report as presented.
2. That the Board of Directors approve the Resolution to recover costs for weed abatement.

BACKGROUND/DISCUSSION

On January 22, 2020, the Board approved issuance of notices declaring a public nuisance and fire hazard at locations in the District where uncontrolled vegetation existed on unmaintained properties. Owners of the parcels were invited to attend the May 27, 2020 Board Meeting if they objected to the District's abatement notice. At the conclusion of that meeting, the Board authorized the Chief to abate the nuisance by removal of the weeds if property owners had not done so by May 27, 2020. The District then instructed its contractor to mow specified properties.

Costs for the weed abatement contractor are passed on to the property owners by the San Mateo County Tax Assessor's Office as a special assessment on the property tax bill. Included in the weed abatement fee are the actual cost to abate the hazard, an administrative fee to recover the District's costs, and the fee charged to the District by the San Mateo County Tax Assessor's Office for their services.

The attached Resolution (Exhibit A) includes total number of parcels mowed and total amount of weed abatement expenses. Each parcel owner is charged individually for the cost of the weed abatement contractor, an administrative fee to recover District costs, Inspectors time, and an administrative fee charged by the County of San Mateo to collect the assessed fees.

If approved by the Board, a copy of the attached Resolution will be submitted to the San Mateo County Tax Assessor's Office for final cost recovery.

WHEREAS, objections of property owners, if any, to the Report have been considered by the Board, and such modifications as the Board deems necessary, if any, have been made to the report; and

WHEREAS, the District has abated noxious or dangerous weeds from 58 parcels and calculated the associated cost for these services total \$29,178.48

1. The report in the form annexed to this Resolution, Exhibit A, is confirmed and approved.

2. A certified copy of this Resolution shall be delivered to the Auditor Controller of the County of San Mateo for collection of the special assessments on the County's property tax roll pursuant to sections 14915 et seq.
